# **Shared Branching Coming Soon!**

You've asked for it, and soon we will be offering Shared Branching to our membership! This convenient service lets you use other credit union branches like they were your own. We know that you are busy and may not always be able to make it to the credit union. With Shared Branching, you can conduct your business virtually anywhere—whether you're in Maine, California, or anywhere in between, there is a Shared Branch nearby. You'll be able to do your routine business wherever you are—deposits, withdrawals, and transfers—wherever you see the Shared Branching logo. Simply bring your account number and a photo ID with you when you use another credit union's branch.

We are very excited to offer this service to our members. If you have any questions about Shared Branching or how to use this service, you may contact any of our knowledgeable and friendly service representatives.

### Tax Season is Here!

Have your tax refund deposited safely and quickly into your account by using Direct Deposit. For a Share account deposit (Savings), use your Share account number found on your account card (without trailers) in the account section. For Share Draft (Checking), use the MICR number at the bottom of your checks beginning with the number 7. Our ABA number is **211288653**.

FYI: Federal deposits are on Fridays; state reimbursement deposits vary. **Do not use a club account as it will be rejected**.
